B.P.Ed. III Semester (Regular, Backlog & Improvement) Examinations, February-2021

It is hereby notified for all the candidates of **B.P.Ed.** belonging to affiliated colleges of Palamuru University that **III-Semester (Regular/Backlog/Improvement)** Examinations are scheduled in the month of **March-2021**. The detailed Time-Table will be notified in due course.

Further, it is informed that the candidates of **B.P.Ed.** who were admitted during the Academic Year 2015-2016 & 2016-2017 (i.e. 2015 Batch & 2016 Batch), **will have to pay Rs.1000/- for each backlog paper in addition to normal examination fee.**

PAPER-WISE IMPROVEMENT IS PERMITTED IN THE NEXT IMMEDIATE EXAMINATION AFTER COMPLETING THE SEMESTER AT A TIME ONLY.

This is the Last Chance to appear for the backlog examinations for the candidates admitted in the Academic Year 2015-2016.

The candidates who were admitted in the **B.P.Ed.** courses prior to 2015-2016 are NOT ELIGIBLE to appear for any of their backlog papers.

GENERAL CONDITIONS TO THE PRINCIPALS

1. **Hard Copy of Examination Application Forms (EAFs) are to be submitted to the Examination Branch duly signed by the student and the principal concerned along with photocopy of qualifying examination. Xerox copies of Examination Application Forms & Photographs will not be considered.**
2. Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if at all they have written the examination.
3. Not to collect the Exam fee (**Collect only Memo fee of Rs.75/-**) from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.
4. As a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their Respective College Principal's account only (students are advised not to obtain the DD in favour of the CONTROLLER OF EXAMINATIONS, PU).
5. **The concerned Principals are required to TRANSFER (Cash deposits/Challans are not accepted) the fee amount through RTGS / NEFT for credit into Registrar, Palamuru University Exam Fee Fund A/c No 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSC Code "SBIN0016375").**
6. The Principals are requested to verify and forward all the Hard Copy of E.A.F. along with the

 - vii. List of Approved Faculty members (Subject wise).
7. The College will be held responsible for any mistake committed while filling the Candidate name, mother name, father name and paper title (Theory & Practical). IN CASE OF ANY MISTAKE RS. 500/- will be levied as FINE for rectification of each error.
8. The late fee amount will be levied automatically in case the fee is not Remitted to the P.U. A/c and forms are not submitted as per the above schedule. A Penal fee of **Rs.1,000/- per day** shall be levied if the college fails to submit the Examination application forms within the stipulated date, i.e., on or before **24-02-2021**.
9. **The Principal is requested to submit the fee for the received application forms only and not to pay fee for un-received application forms. ANY EXCESS FEE PAID CANNOT BE REFUNDED OR ADJUSTED FOR ANY FUTURE EXAMINATION.**
10. **ANY DISCREPANCIES WITH REGARDS TO THE CANDIDATE DATA SUCH AS INTERNAL MARKS, PRACTICAL, AND PROJECTS ETC. SHOULD BE BROUGHT TO THE NOTICE OF CONCERNED OFFICIALS OF EXAMINATION BRANCH AND OBTAIN THE ACKNOWLEDGEMENT WITHIN 15 DAYS OF DECLARATION OF RESULTS. AFTER 15 DAYS, QUERIES WILL NOT BE ENTERTAINED.**
