



REVISED NOTIFICATION

It is hereby notified to all the concerned, that the **M.Ed. IV-Semester (Regular/ Backlog/ Improvement) and II & III Semester (Backlog / Improvement)** examinations for the academic year 2020-21 will be conducted in the month of July/August 2021. The detailed Time-Table will be notified in due course with the permission of the State Government, Telanagana.

Further, it is informed that the candidates of **M.Ed.** who were admitted during the Academic Year 2015-2016 & 2016-2017 (i.e. 2015 Batch & 2016 Batch), **will have to pay Rs.1000/- for each backlog paper in addition to normal examination fee.**

PAPER-WISE IMPROVEMENT IS PERMITTED IN THE NEXT IMMEDIATE EXAMINATION AFTER COMPLETING THE SEMESTER AT A TIME ONLY.

This is the **Last Chance** for the candidates admitted in the Academic Year 2015-2016 to appear for the backlog examinations.

The candidates who were admitted in the **M.Ed.** courses prior to **2015-2016 are NOT ELIGIBLE** to appear for any of their backlog papers.

GENERAL CONDITIONS TO THE PRINCIPALS:

1. Exam application forms duly signed by the student and the Principal concerned along with a photocopy of qualifying examination / Hall ticket should be submitted to the examination branch before the last date. The delay in submission after the last date will attract penalty of **Rs.1000/-** per day. Xerox copies of Examination application forms & photographs will not be considered.
2. The Principals are requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. The examination fee once paid will not be refunded / adjusted under any circumstances.
3. The principals are requested to verify and forward all the application forms immediately along with the Name List (Nominal Roll) in the prescribed Proforma, subject wise data & fee particulars in duplicate.
4. **Not to collect the Exam fee except memo fee from the Visually Challenged, Physically Challenged, Hearing Impaired & Orally Challenged students. A Xerox Copy of Medical Certificate confirming their status as Physically Challenged (Minimum percentage of disability must be of 40%) must be attached to the Application forms. These Students' Application forms should be submitted separately along with Separate Nominal Roll.**
5. All the students are hereby instructed to deposit Examination fee into their respective College Principal's Account only (students are advised to not to obtain Demand Drafts (DDs) in favour of the "Controller of Examinations", PU).
6. The concerned Principals are required to transfer the fee amount through RTGS / NEFT for credit into "**Registrar Palamuru University Exam Fee Fund A/C No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar IFSC Code "SBIN0016375")**" and obtain a receipt from the bank and submit the same to the Examination Branch, P.U along with application forms.
7. Last date for submission of application forms & nominal rolls along with payment slip/Voucher to the Controller of Examinations, P.U. is **13-07-2021**.
