**NOTE:**

1. Cash Deposits/Challans are not accepted. Fee once paid will not be refunded.
2. Filled in application forms (attached with a photocopy of qualifying examination/Hall-Ticket) duly signed by the student and the Principal concerned should be submitted to the examination branch before the last date. The submission of application(s) after the last date will attract penalty of **Rs. 1000/- per day**. Xerox copies of Examination application forms & photographs will not be considered.
3. **Final year students** who have registered for Pharm-D (6YDC) VI Year (Regular) and Pharm-D (3YDC) III Year (Regular) should submit **TWO** certified copies of project report and Hospital report (Report consisting specific objectives and assessment of internship signed by Preceptor concerned) of their internship to the concerned college Principal.
4. The Principal should forward **ONE** Copy of the Project report of each student along with Hospital report on or before **30.08.2021**. The Second copy of the project report has to be kept with the college and the same has to be provided to the Examiner(s) deputed by the University for conducting the Viva-Voce Examination on the specified date(s). **Those candidates who do not register for the assessment will not be considered for taking the assessment. The Principals are requested to contact the Controller of Examination for their final Viva-Voce dates.**
5. **"NO DUES CERTIFICATE"** from the Director, Academic Audit Cell, PU, shall be enclosed with the forwarding letter.
6. **Not to collect the Exam fee (In case of VI (6YDC) & III (3YDC) - Year, collect memo's fee, consolidate memo's fee, provisional certificate fee only from the Visually Challenged, Physically Challenged, Hearing Impaired & Orally Challenged students. A Xerox Copy of Medical Certificate confirming their status as Physically Challenged (Minimum percentage of disability must be of 40%) must be attached to the Application forms. These Students' Application forms should be submitted separately along with Separate Nominal Roll.**
7. The Candidate's/Father's /Mother's name(s) should be submitted to the examination branch as per the qualifying examination(s)/Intermediate Certificate. Any deviation will attract a penalty of Rs.100/- per name correction by the examination branch.
8. Principals are hereby requested not to forward Supplementary candidate's applications.
9. Last date for submission of application forms, nominal rolls and the details of fee paid to the Controller of Examinations, PU is **28-08-2021**.
