All the Pharmacy College Principals are hereby informed that the following details are to be noted for the submission of **Internal Assignment/Assessment, Seminar, Project work Viva & Clerkship of B. Pharmacy I & VIII Semester (Regular), M. Pharmacy I Semester (Regular), Pharm-D (6-YDC) II, III, IV & V Year (Regular) & Pharm-D (3-YDC) I & II Year (Regular)** CBSS for the academic year 2020-21.

1. **B. Pharmacy VIII Semester (Regular), M. Pharmacy I Semester (Regular), Pharm-D (6-YDC) V Year (Regular) & Pharm-D (3-YDC) II Year (Regular) Seminar, Project work Viva & Clerkship** Examinations will have to be conducted for this spell on or before 17-07-2021 in offline mode.
2. For the subjects where the first **Internal Assignment/Assessment** is completed and second is due, the student who has written the first internal has to submit an assignment with answers to one essay type question from each unit which are not covered for the first internal exam. Students who have failed to attend the first internal will have to submit two assignments with answers to one essay type question from each unit. Students who have taken first internal Examination but the Second and Third are due will have to submit two assignments with answers to one essay type question from each unit which are not covered for the first Internal Exam. Colleges have to submit average of two internal marks for B. Pharmacy, M. Pharmacy and average of three for Pharm-D (6-YDC & 3-YDC) on or before **17-07-2021**.
3. Maximum internal assessment marks for all students of B. Pharmacy and M. Pharmacy courses is **25** and Pharm-D (6-YDC & 3-YDC) is **30**.
4. Absent should be noted as **"AB"**.
5. Principals will be held responsible for entries made in the Award List for all the examinations held at colleges.
6. Marks submitted by the college are final and there is no provision for alteration.
7. Hard copies of all the examinations and Internal Assignments Award List along with manual D-Form should be submitted to the exam branch on or before **17-07-2021**. If not submitted, fine will be imposed after the due date.
